LEGAL & LEGISLATIVE UPDATES



Renee Pettinato-Mosley and Neil Colclough

2023 Legislative Summit

Last October, Renee Pettinato-Mosley and Neil Colclough had the opportunity to represent the RIMS community and directly address members of Congress and their staff regarding concerns that impact the risk and insurance industry. This year's agenda included lobby for the reauthorization and broadening of the National Flood Insurance Program (NFIP), the creation of a Federal data privacy act, and the establishment of a federal insurance backstop (similar to TRIA) to address future pandemics and the "Freedom to Invest in Tomorrow's Workforce Act" which would broaden 529 savings plans allowing them to be used for licenses and professional certifications that we see in our industry.

Rocky Mountain RIMS Legislative Report

The Colorado State Legislature kicked off the 2024 session with plenty of internal intrigue. Within the first few days, the GOP Minority Leader Mike Lynch was replaced by Representative Rose Pugliese from Colorado Springs. Bills are being submitted and a few may be of interest to our business RIMS teams, including construction industry wage claims and construction professional insurance coverage transparency. House Bill 24–1108 will require the Insurance Commissioner to perform a study of the state insurance market including availability and cost. This will be a year-long process.




FINANCIAL UPDATES
