On April 4th, the Rising Risk Professionals Group of Chicagoland RIMS hosted Mr. Patrick Rvan for the first installment of the Fireside Chat series. During this event, the insurance stalwart and Aon founder gave a historical overview of insurance innovation as well as his story on how he founded Aon. The event was about entrepreneurship as it pertains to the insurance industry, and was well received by the audience in attendance.
